**ADMISSION NOTIFICATION FOR 2020-21**

Online applications are invited in the format specified for admission to Eight NRI Seats for UG (BAMS) Course at P. N. Panicker Souhruda Ayurveda Medical College, Parakalai, Kanhangad, Kasaragod from candidates who have passed Plus II with minimum 50% marks in Physics, Chemistry and Biology put together and minimum 50% marks in Biology separately as well as qualified in the NEET (2020-21). Subject to the conditions given below.

- Applicants shall furnish scanned copies of their NEET Score Card, Plus II mark sheet , Pass certificate and Age Proof along with the online application.
- Copies of the Passport, Visa, Green Card/OCI documents of their respective Sponsors. Job of the sponsors should be mentioned in the any of the above documents. Visa of the sponsor should be valid till the closing date of admission of BAMS Course.
- In case, the employment of the sponsor is not mentioned in the above documents, the candidate has to produce the employment certificate of the sponsor attested by the Embassy/Consulate authorities.
- The certificate clearly establishing in the relationship of the sponsor with the candidate shall be obtained from the revenue authorities as per GO(Ms) No.243/14/H&FWD dated 6-8-2014.
- The relationship between the candidate and his/her father/mother, which are recorded in the educational certificate, maintained in the usual course of transaction by the competent authorities, shall be accepted.
- The candidate shall be produce a sworn affidavit from the sponsor in a stamp paper worth Rs. 200/-. The same shall be notarized by the Notary Public, disclosing that the student is depended of the sponsor and all expenses ie; tuition fee and special fee of the candidate for the entire course period will be borne by the sponsor.
- All certificate/documents required to establish NRI status/Non creamy layer/Minority etc shall be produced at the time of Submission of application itself. The certificate produce later shall not be entertained under any circumstances.
- The Tuition Fee for admission under NRI quota is Rs.3,00,000/- per year for five years and the Special Fee for 1<sup>st</sup> year is Rs.83406/- and the next four years @ Rs.59244/- per year.
- The last date of submission of online application shall be at 5.pm on 30-1-2021.
- The list of applicants will be published in our Website and Notice Board on 31-1-2021 (after 5 pm).
- The candidates will be given a chance for filing compliance, if any up to 5pm on 2-2-2021 and chance for correction of entry errors will be given at 5.pm on 3-2-2021.
- The Provisional Rank List will be published at 6.00 pm on 3-2-2021 and publication of final rank list on website and notice board will be on 4-2-2021.
