ORDER

1. The Admission Supervisory Committee through order dated 14.01.2021 has provisionally approved the draft prospectus for admitting 15 % NRI quota seats in respect of the KISMA. The P N Panicker Souhruda Ayurveda Medical College ,Kasargod, is one of the member colleges under KISMA, while approving the prospectus, the Committee has issued certain directions and time schedule for admission to BAMS Course 2020-21. As per the time schedule approved by the committee, the last date of inviting online application is 30.01.2021 and the list of provisional rank list submitted before the committee is 03.02.2021.
2. The Principal in Charge, P N Panicker Souhruda Ayurveda Medical College, Kasargod through email dated 05.02.2021 has reported the committee that no NRI applications have been received till the cut-off date of 30th January 2021. Hence, they have requested to permit them to convert

the vacant NRI seats to Management seats.

3. The Committee has gone through the report submitted by the Principal in Charge, P N Panicker Souhruda Ayurveda Medcal College, Kasargod and found that the Ayurveda Medcal College, Kasargod has not received any applications under NRI quota. Therefore, the Committee hereby permit to convert the NRI quota seats to Management seats.
4. The Principal is also hereby directed to collect only the fee fixed by the Fee Regulatory Committee for the 85% seats. The time schedule for taking admission for the management seats is given hereunder:
